7. Pros and Cons of Publishing an Annual Report Discussion

- a. Do you publish an annual report? Why or why not? If so, has it worked? Is it worth the effort you put into it?
- b. Mollie Berg led discussion
- c. One program had a robust annual report for a few years with aggregated data, case examples, and topics of interest and then shifted to a quarterly "newsletter"
- d. Annual reports can be valuable tools to communicate value of Ombuds
- e. Burden in developing report
- f. Reporting is valuable as long as you use it
- g. It's a static, historic document
- h. Beyond a document, it can be a launching pad for robust conversations
- i. It's a place to identify systemic issues, patterns, and/or trends
- j. Some have annual reporting required by Congress
- k. Report can be much work, at times surpassing 100 pages
- I. Some considered white pages and summaries instead of annual reporting
- m. Major recommendations are often included
- n. Good to let public know what external Ombuds are seeing
- Can communicate with stakeholders
- p. Some are shifting to quarterly newsletters and blogs
- q. Reports hold Ombuds accountable
- r. Some refer to them all the time
- s. Reports can serve to highlight issues for new leadership
- t. Agency leaders can use reports
- u. Reports can serve as outreach tool
- v. Some develop mid-year one-pagers to give a snapshot
- w. For externals, annual reports may be best practice to promote program
- x. For internals, concerns exist about creating disincentive to cooperate with Ombuds if sensitive matters between teams disclosed, so some keep systemic information private
- y. Confidentiality issues raised
- z. Showcasing success stories can be valuable; challenge to protect identifying information while maintaining connection to an interesting story
- aa. Reports can serve as vehicles to give tools and resources to the public
- bb. Reports help Ombuds reflect on who we are and how we engage

- cc. Small offices need to assess if trade-offs are worth it; are they missing out on work or outreach with time commitment to reporting?
- dd. Reports can set Ombuds offices apart from the rest of the organization visually
- ee. Though annual reports can show effectiveness, it is not the only way to showcase effectiveness
- ff. Even if not published, could annual report be FOIA'd?
- gg. Reports can memorialize work and show continuity of what Ombuds accomplish and value of Ombuds over time
