### Highlights:

#### 1. Listserv Technical Issues

## 2. IOA Government Sector Meeting Update

- a. The 2018 International Ombudsman Association Conference, to be held April 23-25 in Richmond, VA, will include a number of concurrent sector-specific meetings, including one focused on government ombuds. This meeting will be held from 9:30 – 10:30am on Tuesday, April 24.
- b. A small group of COFO members designed the framework for the government sector meeting around the theme "Tools in Times of Change".
- c. Session participants will separate into small groups focused on one of four sub-topics: Addressing Systemic Issues, Keeping Above the Fray, Serving as a Courageous Ombudsman, and Building Relationship with the New Team.

- d. Group discussions will enable participants to ask questions and share best practices and lessons learned, while networking with fellow government sector ombuds.
- e. Opportunities to continue networking/discussions amongst government sector ombuds will be promoted, including Tuesday's conference-hosted lunch and an informal offsite lunch on Wednesday. Opportunities will be advertised on Whova, IOA's conference app for mobile devices.
- f. Feedback from COFO members indicated some interest in continuing discussions of the sub-topics at future COFO monthly meetings.

### 3. NARA Records Schedule Group Update

- a. Thank you to those volunteering to assist the Executive Committee in working with NARA on developing standard record schedules for ombuds programs.
- b. The COFO Chair has reached out to those who have volunteered with final determinations. If you volunteered and were not contacted, please contact the Chair.
- c. COFO membership will be provided updates on progress at future monthly meetings.

# 4. ABA Ombudsman Committee Report

- a. Each February, the American Bar Association's Ombuds Committee is featured in ABA's Just Resolutions e-newsletter. - b. The ABA Board recently approved an Ombuds Committee proposition to establish October 11, 2018 as "Ombuds Day". Activity planning is underway, and will include both on-line and in-person engagements, including a panel discussion at the ABA.
  - i. The planned outcome of "Ombuds Day" is to spread knowledge and encourage greater interest in ombuds, engaging a wide variety of stakeholders and topics.

- d. The ABA's Women in Dispute Resolution Committee has been considering the efficacy of diversity elements leveraging work done by the State of New York, which may have some interest to COFO members. Updates will be provided in future meetings.

# 5. COFO Annual Conference Update

- a. The COFO Annual Conference is tentatively planned to be held at the US Patent and Trademark Office (Alexandria, VA) in October.
- b. A conference planning volunteer group is being put together to assist in generating ideas for topic areas and speakers. Volunteers are also sought for logistical support on the day of the conference.
- c. A Listserv message will go out with relevant contact information. COFO members interested in joining are asked to identify themselves to Bina Patel (Bina.M.Patel.Civ@mail.mil) and Tyler Smith (Tyler.Smith@nih.gov) by April 30.

## 6. Mentoring Program Update

a. The purpose of the program is to promote best practices and encourage cross-fertilization amongst COFO members and their organizations.

- b. Program design is complete and has been shared with a small group of reviewers before submission to the Executive Committee.
- c. Some key parameters
  - i. Mentors should have three years' experience as practicing ombuds; Mentees should be practicing ombuds.
  - ii. Applicants to both positions will apply to a mentoring committee for acceptance; the committee will match mentors with mentees based on function and other parameters. There will be 2 matching rounds per year (January and June)
  - iii. Generally speaking, designers are looking at 2 hour/month commitments for 6-12 months of both mentors and mentees.

- b. Shared Neutrals Program It was announced in the April 11 Interagency Dispute
  Resolution Working Group that HHS will discontinue its coordination support for the
  Shared Neutrals Program for the National Capital Area due to budget constraints. A path
  forward for continuing the service has not been determined. Questions included
  whether there was a possible COFO role in encouraging the program's continuation.

### 8. Discussion Topic: Resolution of Interagency Conflicts

- a. To what degree do ombuds offices work across agencies to resolve differences of opinion or to promote clarity for example, when there is disagreement on taking credit for accomplishments?
- b. From the discussion, there does not appear to be wide spread, interagency engagement. In at least one case, an office was chartered to support such engagements but had not yet exercised that authority.
- c. Related questions arose, including
  - i. Implications for neutrality if an ombuds for one agency is engaged to assist the resolution of an interagency dispute.
  - ii. Implications for making ombuds services available to others not directly affiliated with your organization (e.g., a stakeholder group).
