### 3. ABA Dispute Resolution Section Ombuds Committee Update

- a. The Committee has been working towards developing the Model Organizational Ombudsman Act. The purpose of the Act is to create a model statute which defines what an organizational ombuds is and codifies protections for the role, which may impact Federal ombuds programs. The hope is that state legislatures will pass this Act into law in their jurisdictions. The Committee is finalizing the document and will it send out to the federal ombuds community for comments.

# 4. Ombuds Research Survey

- a. Tyler Smith from NIH has been working for years with his colleagues in higher education (Shereen Bingham, University of Nebraska at Omaha; Bryan Hanson, Virginia Tech; Andrea Griffin, Indiana University Northwest) to develop a tool that measures perception. The primary goal of this tool is to understand perceptions across the organization that enables ombuds to consider the impact of their practices and how they frame communication about their office.
- b. Currently, the tool has been piloted in academic internal ombuds organizations. The group would like to extend the pilot study to the federal sector. Tyler and his colleagues are seeking volunteers to answer a 2 minute preliminary anonymous survey on this topic. Tyler will send out an email containing a link to take the survey. ### 5. IOA Conference Updates & Requests

a. The government sector discussion will be facilitated by Deanna Yuille (FDA), Elisa Enriquez (Los Alamos Laboratory) and Bina Patel (NGIC). The discussion topic: addressing harassment in the workplace. It is a 360 degree discussion that is designed to address harassment in the workplace for both external and internal ombudsman. ### 6. Discussion Topic: Early Warning Signs

- a. How do you get early warnings out in the agency? Who do you go to report early warnings?
  - i. Participants shared best practices of how they would handle early warnings in their agencies. Examples include,
    - 1. The importance of building rapport in a professional working relationship, one that encourages an understanding of independent boundaries, with individuals of influence such as Human Resources, Senior Leaders, and/or Legal Counsel).
    - Early warnings may include sensitive topics and depending on the issue, as ombuds, we have to remain flexible to developing professional relationships with leadership in the organization to comfortably report it.
    - 3. Due to confidentiality, it can be challenging to report early warning signs. A few ways to report early warning signs without releasing confidentiality: collect trends associated with a specific issue and early warning; research on the issue to gather information and report it as a general trend or major outlier. Some agencies are required to report early warning signs such as potential whistleblowers or IG complaints and obligated to report it.
    - 4. For both external and internal ombuds, calculus to report early warning signs is not necessarily different. Whether the issue reported is external or internal, the ombudsman must seek to build professional working relationships within the organization to report early warning signs.

- 5. Early warning is a function of what the ombuds does and not necessarily a process. Currently, a defined process of reporting early warning does not exist.
- ii. Suggestion: continue to develop professional partnerships that offer trust and rapport, encouraging difficult conversations to take place, when needed, specifically to report early warning signs.
- iii. Takeaway: When addressing early warning signals, it is important to act upon the ombuds principles of practice to ensure neutrality, confidentiality and independence are not compromised to attain a successful working relationship. It is a mutual layer that is dependent upon building partnerships with other internal functions.
