## • Discussion Topic

- In advance of a session on this topic at the ABA Dispute Resolution Spring Conference, a discussion on the value of online education for ombuds. From ABA DRS Ombuds Subcommittee Chair Ken Skodacek: "From my perspective, especially related to Ombuds Day, an online format has allowed us to engage a larger audience and has also allowed us to have speakers that would otherwise be difficult to coordinate in more traditional, in-person, sessions. I have also benefited from online training from USOA, IOA, and COFO. I would like to hear your thoughts on this important topic. What are the benefits of online education for ombuds? What experiences and insights do you have to share about online education? What's the future of online education, especially post-pandemic?"
- Benefits include: ability to watch videos from other sessions later, online polls, breakout rooms, chat boxes, ability for international audience to attend, makes it more affordable. Feels easier to connect with people online now.
- Challenges include: Loss of interpersonal connections, when networking is so important.
