Highlights:

1. COFO Membership Location

a. Location: June meeting will be held at the Smithsonian, 1100 Jefferson Street.

2. COFO Mentoring Committee Update

The Mentoring Committee has begun their June Cohort, second cohort. We have six mentor candidates, three mentee candidates (three pairs). We look forward to reaching out to our mentors and mentees following the matching process. The Committee has decided to hold two cohorts a year. The next cohort will take place in January 2020 and we will begin taking applications in October 2019. Requirements for mentor/mentee include,

- a. Mentee candidacy: be a current practicing ombuds
- b. Mentor candidacy: practiced in the ombuds function previously or currently for a minimum of three years

3. ABA Dispute Resolution Conference Reflections

a. The conference was successful in presenting a variety of issues ranging from current opioid crisis, sexual harassment, ombuds (what's in the name), to access to legal counsel in rural areas.

4. Ombuds' Day: 10 October, 2019

- a. Theme: Ombuds: Unusual Name, Important Service
- b. The goal of this event is to increase awareness of the ombuds role with the public. The committee is currently working to make Ombuds Day an official day via local governments.
- c. The awareness will serve to emphasize the importance of the function. The committee encourages all ombuds serving in the private and federal sectors to celebrate this day. A toolkit with templates will be released soon. Practitioners are encouraged to celebrate

- this day by enhancing the awareness through their agencies, senior leader buy in, social media, and local news.

- **4. Discussion Topic: Bullying:** How do we define bullying? How do we identify bulling in our day to day work?
 - a. Definition: A pattern of behavior displaying power imbalance and level of aggression against another individual.
 - i. WorkplaceBullying.org presents a definition: "Workplace Bullying is repeated, health-harming mistreatment of one or more persons (the targets) by one or more perpetrators. It is abusive conduct that is: Threatening, humiliating, or intimidating, or Work interference sabotage which prevents work from getting done, or Verbal abuse."
 - b. Where is the line between harassment and bullying? The line is determined by the pattern of behavior against a targeted individual. The main element is the impact the aggressive behavior has on an individual who is targeted.
 - c. NSA is currently working on an anti-harassment policy that includes a definition of bullying (in accordance with DoD Regulation 1020.03).
 - d. Passive bullying is experienced when one individual is targeted in a group, impacting others in the group who become fearful of speaking up, changing the behavior and dynamic of the entire group.
- **5. Your Topic:** An open forum-space for new ombuds practitioners to ask questions and/or share thoughts to COFO members. We will continue this space for all meetings going forward.
 - a. A request for an instruction on scientific conflict resolution: Specifically, the request is to help with how to manage scientific conflict resolution and what type of information may be shared (within a peer review model). The request should also provide guidance on how to interface internal with external dispute resolution.
 - b. FOYA: need assistance or guidance on what we release to FOYA vs confidential information
 - Under the Alternative Dispute Resolution (ADRA) Act, exemption 3: there is verbiage on the release of records. ACUS study addresses similar guidance on release of records.
