4. Discussion Topic:

- **a.** Ombudsman as Trainer Do you offer training to the agencies you ombuds or, for externally-facing ombuds, your stakeholders? If so, on what do you conduct training, and how do you socialize its availability to the target audience? Any special considerations when either publicizing or delivering the training to maintain an independent posture and differentiate your program from your agency?
 - i. Suggestions/Recommendations from COFO members:
 - 1. The Ombudsman training differs in each agency. Ombudsman are offering training to internally and externally stakeholders. Internally, training may be in partnership with other departments, or conducted only in the Ombudsman function.
 - Topics for trainings range from Myers Briggs, Crucial Conversations to Conflict Resolution 101. Materials for the trainings are created independently by Ombudsman.
 - 3. Members of COFO also shared logistical options. Some agencies independently conduct logistics, while others are routed through the training departments.
 - 4. In some agencies, training does serve as an effective tool to advertise the Ombudsman function, despite conducting training in partnership with internal groups such as EEO/Training Office.

a. ROI Institute will be hosting a 5 day training, "Measuring the ROI of Soft Skills" from August 20-24, 2018 in Washington D.C. The purpose of the training is to show value in soft skills through metrics and ROI. The training will be followed by a capstone study on how to build metrics and speak to stakeholders.
